GENERAL BUSINESS

**MR. AND MRS. MURRAY M. WEBB
SCHOLARSHIP**

Eligible: This scholarship is for the purpose of attracting superior students to the College of Business in order to enhance the overall academic quality of graduate programs. Each year the Dean=s office will select a top **MBA** candidate as the recipient of the scholarship.

Amount: \$700.00 awarded annually

**KENNARD SEFORTH VARN
SCHOLARSHIP**

Eligible: The scholarship will be awarded to an outstanding student majoring in business at the University of West Georgia. The recipient should be a **resident of Ware County or an adjacent county: (Clinch, Atkinson, Coffee, Bacon, Pierce, Brantley, or Charlton).**

Amount: \$450.00 awarded annually

D.W. BROOKS/GOLD KIST OF WEST GEORGIA SCHOLARSHIP

Eligible: This scholarship shall be awarded annually to a business major with a **GPA of 3.0** or greater who is from one of the following five counties: **Carroll, Heard, or Haralson in Georgia and Cleburne or Randolph in Alabama.**

Amount: **\$500.00 awarded annually**

HUGH W. RICHARDS MEMORIAL SCHOLARSHIP

Eligible: This Scholarship is awarded to a rising **junior or senior** majoring in business at the University of West Georgia. Selection is based on demonstrated academic ability and promise as well as need.

Amount: Two scholarships will be awarded for **\$1,000.00** each.

FRIENDS OF FRED SCHOLARSHIP (Fred Hutchins Scholarship Endowment)

Eligible: This Scholarship is awarded to at least two students (**one graduate and one undergraduate**) who **have and maintain an overall GPA of 3.0 or higher.** The student(s) must have graduated from a high school within **Carroll County**, or **be a Carroll County resident or employed by a Carroll County banking institution.** Selection is also based on strong moral character and a sense of responsibility to the community.

Amount: Two scholarships will be awarded for **\$2,150.00** each

YEAGER FAMILY SCHOLARSHIP

Eligible: Undergraduate **junior or senior** majoring in business with an overall grade point average (**GPA**) of **3.0 or higher**. The scholarship may be renewed for an additional academic year provided the recipient meets the requirements.

Amount: \$500.00

CHARLES W. COX MEMORIAL SCHOLARSHIP FUND (One, Two or Three Scholarships)

The purpose of the Fund is to help attract superior students to the College of Business who will enhance the overall academic quality of both graduate and undergraduate programs.

Eligible: This scholarship will be designated for **MBA graduate students**, as well as **junior or senior** students majoring in **Finance, Management or Marketing**.

Amount: Award is **\$500.00** each for one undergraduate and one graduate student.

JAMES B. LIPHAM SCHOLARSHIP

Eligible: This scholarship will be awarded to an outstanding entering freshman majoring in business administration at the University of West Georgia. Priority will be given to students residing in **Muscogee County**. High school grade point average (**GPA**) of **3.0 or higher and combined SAT score of 1012, or ACT Composite score of 21**. The scholarship may be renewed up to four years provided the recipient meets the requirements.

Amount: \$500.00

MANAGEMENT DEPARTMENT

FRANK HUNSICKER MEMORIAL AWARD

Eligible: This scholarship is awarded to a **senior management major** with a **GPA of at least 3.2** and who most exhibits the qualities of leadership, managerial ability, professional achievement, and integrity associated with the discipline and exemplified by Dr. Hunsicker. This scholarship is awarded to a qualified student chosen by the department.

Amount: **\$950.00**

HENRY M. CAMERON SCHOLARSHIP

Eligible: The scholarship shall be awarded annually to a **sophomore, junior** or **senior** majoring in **Management** at the University of West Georgia. The recipient must be a resident of **Carroll, Polk, or Troup County** or from the State of Georgia. Selection shall be based on merit and financial need.

Amount: **\$350.00 awarded annually**

GIBSON/OVERTON/PEETE SCHOLARSHIP AWARD

This scholarship is to be awarded annually to a student majoring in **Business Education** by the Management and Business Systems Department.

Amount: \$500.00 awarded annually

EARLINE J. POWERS BUSINESS EDUCATION SCHOLARSHIP

Eligible: This scholarship is to be awarded annually to a **rising junior or senior** majoring in **Business Education** at the University of West Georgia. The award shall be based on academic success and financial need with preference being given to students from **Carroll, Fulton, DeKalb, or Stephens County, Georgia.**

Amount: \$500.00 awarded annually

ECONOMICS DEPARTMENT

SUZANNE LANKFORD SULLIVAN MEMORIAL SCHOLARSHIP

Eligible: Economics major who is a graduate of a Carroll County High School.

Amount: \$750.00

W. GLENN MOORE MEMORIAL SCHOLARSHIP

Eligible: Recipient shall be a student in the Economics program at the University of West Georgia.

Amount: \$500.00 awarded annually

DR. MICHAEL D. RAPER MEMORIAL SCHOLARSHIP

Eligible: Recipient shall be an Economics major with a 3.0 GPA or higher.

Amount: \$650.00 awarded annually

ECONOMICS DEPARTMENTAL AWARD

Eligible: Economics majors who have a minimum 3.0 GPA and have completed two principles of economics courses.

Amount: \$420.00 (can be one or two awards)

ACCOUNTING AND FINANCE DEPARTMENT

JIMMY COUCH MEMORIAL SCHOLARSHIP

Eligible: This scholarship is to be awarded to a **Carroll County junior or senior majoring in Accounting**. The award is based on need and a GPA of at least 3.0. The department will choose the recipient.

Amount: \$500.00

NAOMI L. SATTERFIELD SCHOLARSHIP

Eligible: This award will be designated to a **junior or senior accounting major**. The student will have completed Accounting Principles, Intermediate Accounting 1, and one other accounting course in the major; be employed at least part-time and have a minimum **GPA of 3.0**. The department will choose the recipient.

Amount: \$1,200.00 (divided between two or more recipients)

GARRETT, STEPHENS, THOMAS, P.C., SCHOLARSHIP

Eligible: This scholarship is to be awarded to a junior, senior, or graduate student from **Carroll, Haralson, Polk, and Heard Counties** majoring in **Accounting**. Financial need is considered. The department will choose the recipient.

Amount: \$500.00
