July 12, 2000

Dean Jenkins stated that graduate enrollment is up over last summer. He thanked the College of Education and others for their recruitment efforts.

Dr. Gregory Stewart stated that their night masters degree program in Biology will begin this fall. All courses for this program will be offered during a five year period.

Dean Lumpkin reported that the UWG has received approval as a level five (doctorate granting) institution. Seventeen students have been accepted into the College of Education's new doctoral program in School Improvement.

Dean Lumpkin also stated that the College of Education has received a three year 2.5 million dollar grant that will allow faculty to observe student teachers in five different cities from their offices.
