

**UWG ADVANCE-IT Catalyst Project (2012-2014)**

Principal Investigators: Drs. N. Jane McCandless, Catherine A. Jenks, Nancy Penco, L. Michael Johnson, and Dianne Hoff. National Science Foundation (NSF) funded project to assess campus culture and climate and work-life balance as they relate to the lack of recruitment, retention, and promotion of female faculty in STEM and social science disciplines. Designed and fielded a paper and pencil survey of UWG faculty in STEM and science related disciplines.

**Carroll County Drug Court Process Evaluation (2013)**

Conducted a process evaluation of the drug court.

**University of West Georgia Branding Initiative, Wave 3 (Spring - Summer 2013)**

**West Georgia Area Survey (August – December 2010)**

Inaugural survey of seven west Georgia counties (Carroll, Coweta, Douglas, Haralson, Heard, Paulding, and Troup) to collect baseline measures of area demographics, social capital, and public opinion on social issues including the environment and crime. This cross-sectional study served as the baseline for an annual survey of the area.

**University of West Georgia Graduate Enrollment Survey (August – November 2010)**

Developed and fielded web surveys for prospective and current graduate students at the University of West Georgia to ascertain barriers to enrolling in graduate programs offered at the university and develop strategies to overcome those barriers.

**University of West Georgia Branding Initiative, Wave 1 (March – May 2010)**

Conducted focus groups of faculty, staff, undergraduate and graduate students, alumni, and community members, and developed CATI and Web surveys for UWG Institutional Advancement. Freshmen political science students placed voting reminder calls to over 1,000 residents in Carroll County the week before the November presidential election as part of the iServe Mentor Program.

**Ambivalence toward Crime Control and Due Process Using SIM (March – May 2008)**

RDD CATI survey that examined the conflict citizens encounter regarding crime control and due process. The Similarity-Intensity Model (SIM) for testing attitudinal ambivalence was tested as a viable method via CATI to ascertain the presence and extent of ambivalence among citizens regarding the government providing counsel to criminal defendants who cannot afford an attorney.
