### **Agenda Item #1 – Approval of December 5, 2009 Minutes**

### **Agenda Item #2 – Update on Academic Standards Change and Re-Instatement Policy (Scot Lingrell)**

A new category of academic standing was proposed at the Dec 5 meeting. See *Academic Standards* handout.

### **Discussion**

- Perry requested numbers regarding how many students this proposed change will impact.
- This essentially creates two terms of probation. Students do not have the option of returning to academic warning, but could return to Academic Probation.
- Minimum GPA requirements need to reflect the GPA requirements for the number of hours, minimum term GPA is 2.0.
- Departments can require additional intervention.
- General Re-Instatement Policy: revisit at a later date.

Scot will be requesting for Committee approval of the Academic Standing Policy at the next meeting.
