### Faculty Development Committee: Online Dossiers and CV Template

At its March meeting Faculty Senate voted unanimously to approve a proposal from the Faculty Development Committee to require that all materials related to pre-tenure, tenure and promotion, and post-tenure reviews be submitted online effective Fall 2018. The goal is to increase efficiency in the transmission of materials. The Senate also approved the removal of the CV template from the faculty handbook, in order to allow faculty undergoing review to present their CV in the format most appropriate for their discipline.

### Academic Policies Committee: Online Course Evaluations Part III

At its March meeting the Faculty Senate approved modifications to the student course evaluation form used for online courses. The new online course evaluation form will go into effect in Summer 2016.

### General Faculty Meeting: Online Voting
