meeting that he supports having psychology students take four semesters of a foreign language as a matter of principal.

- A rationale for change was not provided. The committee requested a rationale.
- There was no evidence of dialogue between the Psychology and Foreign Languages and Literatures departments.
- Committee questioned if the Psychology proposal was counter to Requirement # 7 of the “Specific Requirements for Bachelor of Arts Degree” heading of the 2010-2011 Undergraduate Catalog.
- Committee requested clarification of how the retroactive change would be implemented.
- FLL visitor questioned why FLL 2001 and 2002 are not electives in Area F although new electives (ART, CROM, ECON, ENGL, GEOG, and MUSC) have been added.
- FLL visitors requested for consideration that Foreign Language 2001 and 2002 be added as electives in area F.
