Position Description and Qualifications: Tenure-track academic-year faculty appointment available. Nurses in all clinical specialty areas are sought including nurse practitioners and those with backgrounds in informatics, nursing education, and nursing leadership. Responsibilities include graduate and undergraduate teaching in online and traditional classroom settings; simulation, laboratory and clinical instruction; and scholarly productivity in a supportive environment. Applicants are required to hold a graduate degree in nursing with a clinical background in specialty area(s), an earned doctorate in nursing or a related field, and have an active RN license (or eligible) to practice nursing in the state of Georgia (eNLC).

**Preferred Qualifications**: Teaching experience, ability to work with diverse populations of students, certification as a Clinical Nurse Leader, and evidence of a scholarly program are preferred. Rank and salary are commensurate with qualifications and experience.
