Rationale: Adding a special education track to the existing MAT program. The Georgia Board of Regents (BOR) has defined Master of Education (M.Ed.) degree programs as advanced programs. Thus all M.Ed. programs offering initial certification must be reconfigured into a Master of Arts in Teaching (MAT) degree program which the BOR defines as a program that leads to initial teacher certification. Since we will continue to offer our M.Ed. in Special Education for candidates already holding certification, we are asking to modify the existing M.A.T. program to include a track for Special Education for candidates seeking initial certification in Special Education. We have tried to reflect important aspects of the current MAT programs, as well as components to best meet the needs of candidates, children, and all stakeholders involved in public P-12 education. Special education is still a high-need field and currently school systems have no choice but to hire some personnel who only hold temporary (provisional) certificates in this field. This program can meet the needs of those teaching on provisional certificates, as well as offering a vehicle for those who wish to enter this area of education.

Rationale: Bacterial Pathogenesis has been taught for several semesters as a special topics course in biology at both the undergraduate and graduate levels (BIOL 4985/6985 Special Topics in Biology). The course has proven to be very popular among M.S. students in biology planning careers in medicine or fields in the biomedical sciences. The course is a forerunner of what students typically encounter in medical school microbiology courses. The number of medically-related, graduate-level biology courses offered each semester is currently limited. This forces some of our M.S. students interested in the medical field to take other courses in order to complete the course requirements for the M.S. degree (10 courses for non-thesis track students and 7 courses for thesis-track students). For that reason, Bacterial Pathogenesis is a critical course for many of our graduate students interested in medicine and the clinical sciences. Furthermore, the addition of Bacterial Pathogenesis (BIOL 4728/5728) will create a series of graduate-level courses in medical/clinical microbiology to also include Essentials of Immunology (BIOL 5727), Medical Virology (BIOL 5729), and Emerging Pathogens (BIOL 5730). As a requirement of the course, graduate students enrolled in BIOL 5728 must complete an oral PowerPoint presentation based on an article from the Morbidity and Mortality Weekly Report (MMWR) published by the Centers for Disease Control and Prevention (CDC). Graduate students will also draw relevant background information from other sources such as review articles and book chapters and incorporate that information into their MMWR presentation. An online, virtual laboratory component is planned which will familiarize students with laboratory techniques routinely used to isolate, culture, and identify bacterial pathogens from clinical specimens.

Rationale: The M.S. in Applied Computer Science is a 100% online program with a cohort matriculation model; students must enter in the Fall semester and may complete the program in two years (6 consecutive semesters including summers). The prerequisite structure of the program requires students to take courses in a specific order. Students failing to complete a course or choosing not to take a course according to the cohort rotation will fall behind and must wait an entire year before they are able to continue their matriculation in the program. This structure, as well as, the frequency of change in specific course content necessary to remain current with the field, necessitates that students progress through the program with continuity and according to the rotation. It is important, as an online program with no face-to-face interaction among students, that students progress along with their cohort peers to maintain the community necessary for student retention and effective completion of various group-oriented assignments and projects. Furthermore, shortening the duration from six to three years will align the program with national benchmark standards of similar online programs.

A 3-year time limit will benefit students by encouraging them to stay engaged and complete the program in a timely manner. This will improve graduation rates and help the department to effectively plan for resource needs to support the program.

D. Sub-committee report on "Grade Replacement Policy" review. (Myrna Gantner, Kareen Malone, Nancy Pencoe, and John Ponder)

Discussion: Myrna explained that due to "Banner", grade replacement for graduate programs must be consistent with the "undergraduate policy" however, programs may still have different policies. If programs have a different policy, their grade replacement must be manually handled by contacting the Registrar. This process will not change; however, each program is encouraged to review their program's policy to assure consistency with its application to students.

E. Introduced topic: Receipt of Transcripts by Schools/Colleges

Discussion: The topic of "receipt of transcripts" by the colleges was introduced by Doug. He expressed concern that when the schools/colleges receive transcripts (which should go directly to the Registrar) that they are not always marked as "transcripts", so they are inadvertently being opened which is in conflict with university policy. It is believed that he decentralization of the graduate school functions which moved the transcript receipt and review process responsibility to the Registrar' office has compounded this problem. Myrna expressed that this topic would be a discussion point at the next Dean's meeting in order to investigate an acceptable alternative.

### **Appendix A. Revised Shared Governance Procedures**

The process of notification and approval for the creation/modification of academic programs and curriculum is outlined below:

### 1. The following are *actions items* by the Senate and appropriate Senate Subcommittees:

- New academic programs and new courses (degrees, majors, minors, concentrations, certificates, etc...)
- Changes to a course level (i.e. changing from 3000 to 4000 level)
- o Adding to or removing a course from the Core Curriculum
- Changes to course prerequisites that span across colleges
- Modifying the requirements to complete an academic program, including core curriculum
- New or modified concentrations within a degree program

### 2. The following are *information items* for the Senate:

- Modifications to XIDS courses (Action Item by the Committee)
- o Changes in admission standards for an academic program
- o Suspending (deactivating) or eliminating (terminating) academic programs
- o Offering an existing academic program more than 95% online
- Offering an approved academic program more than 50%, but less than 95% online

# 3. The following are *reviewed by the Senate graduate and undergraduate programs* committees to assure quality of academic programs

- o Comprehensive Program Reviews
- Academic program and core curriculum learning outcome assessments

## 4. The following are *not items considered* by the Senate and should be reported directly to office of the Provost:

- Modifications/additions/deletions to existing academic program learning outcomes, excluding core curriculum
- Offering less than 25% or 25-50% of an academic program at an off-site location or online (separate notifications for each change)
- Minor modifications to courses including: course name, description, course learning outcomes, and prerequisites within a college or school
- Creation or modifications of assessment artifacts
- Moving an approved course to online delivery (including both "D" and "N" sections)

### Appendix B. Time Limits to Complete a Graduate Degree

### Time Limits to Complete a Graduate Degree

(Draft revision for February 28, 2013, GPC)

### **Existing Text:**

Degree programs in the College of Education must be completed within seven years.

The Ph.D. in Psychology: Consciousness and Society program must be completed within eight years.

All other graduate degree programs must be completed within six years.

It is expected that a student will complete the degree program with reasonable continuity. A student called into military service or a student with extraordinary circumstances may apply for an extension of time. The student should submit the **Degree Time Limit Extension Form** and a letter of appeal to the director of his/her graduate degree program. The time limit exception must be approved by both the Program Director and Director of Graduate Studies in the college or school.

#### **Revised Text:**

Degree programs in the College of Education must be completed within seven years.

The Ph.D. in Psychology: Consciousness and Society program must be completed within eight years.

The M.S. in Applied Computer Science program must be completed within three years.

All other graduate degree programs must be completed within six years.

It is expected that a student will complete the degree program with reasonable continuity. A student called into military service or a student with extraordinary circumstances may apply for an extension of time. The student should submit the **Degree Time Limit Extension Form** and a letter of appeal to the director of his/her graduate degree program. The time limit exception must be approved by both the Program Director and Director of Graduate Studies in the college or school.

Request for Specific Time Limit for the M.S. in Applied Computer Science Program 2/4/2013

The Department of Computer Science requests that the Graduate Catalog policy, "Time Limits to Complete a Graduate Degree" be modified to stipulate "The M.S. in Applied Computer Science program must be completed within three years.

### Rationale:

The M.S. in Applied Computer Science is a 100% online program with a cohort matriculation model; students must enter in the Fall semester and may complete the program in two years (6 consecutive semesters including summers). The prerequisite structure of the program requires students to take courses in a specific order. Students failing to complete a course or choosing not to take a course

according to the cohort rotation will fall behind and must wait an entire year before they are able to continue their matriculation in the program. This structure, as well as, the frequency of change in specific course content necessary to remain current with the field, necessitates that students progress through the program with continuity and according to the rotation. It is important, as an online program with no face-to-face interaction among students, that students progress along with their cohort peers to maintain the community necessary for student retention and effective completion of various group-oriented assignments and projects. Furthermore, shortening the duration from six to three years will align the program with national benchmark standards of similar online programs.
