The review of the CPR in Real Estate was APPROVED with the following concluding paragraph (to replace the concluding paragraph in the draft):

Based on the documented efforts communicated in the CPR to increase recruitment, enhance program quality, and develop a robust assessment process in the past five years, the program

appears to be viable provided that sufficient faculty lines are maintained. In the absence of sufficient faculty lines, the faculty reviewers would encourage RCOB to explore ways to maintain Real Estate offerings through measures such as making the program a track of another major, or through merging with another major.
