## EVALUATION

Grading for this course will be on a point system based on your performance on the exams, problem sets, and in-class/online assignments. The assessments will be based on the assigned readings, lectures, assignments and exercises.

**Problem Sets:** There will be **FOUR Problem Sets** and these will be due at the **beginning of class** on the Review Day and **NO** late work will be accepted. **Your lowest Problem Set score will be dropped.** Solutions to the problem sets will be posted in Course Den after the deadline. **Requests to turn in problem sets after the deadline will be denied. NO MATTER THE REASON.**

**In-Class & Online Assignments:** There will be randomly assigned in-class and online assignments to reinforce topics covered in class. These may not be announced in advance and cannot be made up. No exceptions.

**Exams:** There are **four exams** each worth a total of **75 points**. **Your lowest Exam score will be dropped. (There are NO make-up exams.** If you miss any regular exam, your score of 0 will count as your lowest to be dropped.) Exam questions will be a combination of multiple choice (with the professor providing scantrons), short answer questions, math problems, and questions related to case studies. **Only basic function calculators are allowed during the Exams— No cell phones, graphing calculators, and no sharing!**

**Final Exam:** There will also be a **CUMULATIVE** Final Exam worth 100 points. **The Final Exam score cannot be dropped.**

## **Bonus Points:**

- **Online Quizzes:** There will be four online quizzes and each must be completed through CourseDen. All quizzes end at 11pm the day before a scheduled exam. Missed quizzes CANNOT be made up. Quizzes have unlimited attempts and the points earned from the highest attempt will be added to the next exam score. Quiz attempts will not be adjusted (even if there are issues with quiz questions).

- Additionally, **bonus points** may be given out at **the discretion of the professor**. Bonus points may be allocated based on random attendance checks, class participation, or attendance at special campus events.

The overall objective of this course is for you to learn basic economic concepts, specifically macroeconomics, and more about the economic system in which we live. To this end, upon completion, students will:

- Be able to describe basic economic concepts such as scarcity and opportunity costs (LG4, LG7, LG8)
- Demonstrate a basic knowledge of macroeconomic concepts such as gross domestic product, inflation and unemployment (LG4, LG7)
- Demonstrate a basic knowledge of international economics including concepts such as exchange rates and net exports (LG4, LG5, LG7, LG8, LG9)

- Demonstrate a basic knowledge of the banking system, the impact of the Federal Reserve on the economy, and government taxation and spending policy (LG7)
- Be able to analyze the effectiveness of fiscal and monetary policy in combating inflation or unemployment (LG4, LG7, LG10)
- Be able to apply macroeconomic models such as aggregate supply and demand to the analysis of current economic issues (LG4, LG7, LG9, LG10)
- Demonstrate an understanding of the social, cultural, and / or political development of the people and institutions of the United States (US Perspectives Core Overlay)
